This is to inform that the reference to the notice *IIP/RDC/Even Sem. 18-19/01, Dated: 01.03.2019*. RDC has revised the following policy norms that are to be considered with immediate effect with respect to sponsoring the faculty & students for publication in National International Conferences.

1. For Students - Rs. 1000/- (one time only as cash award for the first author) to publish their research work in good quality conferences and journals.
2. For students - 50% of registration charges (one time only as cash award for the first author subjected to a max of Rs. 5000 /-) to publish their work in UGC-care listed /SCI/Scopus Indexed journals.
3. Research grant will be released to only either first or corresponding author belongs to the institute. paper published in SCI/Scopus indexed journals will be awarded Rs.5000/-
4. Paper Published in SCOPUS indexed journal will be awarded Rs.3000/-
5. Paper Published in UGC/Web of science indexed journal will be awarded Rs.2000/-
6. Conference seminar workshop fees for paper presentation at internal level will be awarded up Rs.5000/-
7. Registration fees of copyright and patent will be paid by the institution. (As per recommendation of institute R&D cell if considering institution affiliation name along with claimant must).
8. Book publication will be awarded as per following norms:-

Book with national publisher and ISBN No.	Rs.1000/-
Book with international publisher and with ISBN No.	Rs.2000/-
Edited Book chapter with national publisher and with ISBN No.	Rs.500/-
Edited Book chapter with International publisher and with ISBN No.	Rs.1000/-

Faculties are advised to publish their paper in SCI/Scopus indexed free journals. The quality of the journal and that of the paper be reviewed by RDC before they proceed for the registration all the paper published should hear the institute name in the affiliation part to be considered for the above mentioned






Faculty and students who wish to apply for the rewards are required submit the following.





