1.1.2 The institution adheres to the academic calendar including for the conduct of Continuous Internal Evaluation

At the beginning of each semester, the IQAC (Internal Quality Assurance Cell) prepares the academic calendar based on the schedule provided by RGPV University. This calendar includes various curricular activities and key dates such as:

- Session Commencement date
- Details of holidays
- Dates for Sessional Examinations
- Internal assessments
- Last working day
- Tentative dates for university practical exams and end-semester exams

Once the calendar is approved by the principal, it is uploaded to the college website, displayed on notice boards, and communicated to students WhatsApp group.

The Institute adheres to the academic calendar and scheme provided by the University for the conduct of a CIE system. Continuous Internal evaluation in the institution is transparent and robust and is in compliance with **Internal Exam Policy**. It includes advanced mentoring, academic calendar, grievance redressal, uploading the internal marks in the university portal.

The institution has in-house examination committee to oversee the conduct of the internal assessment tests. The process of internal evaluation starts at the classroom level. For each subject two internal tests are conducted before each semester giving fair chance to the absentees due to permissible circumstances and thus bring students under a uniform internal evaluation system. The college internal assessment exam committee frames the guidelines for conducting CIE.

The following reforms have been carried out for CIE:

1. **Time table:** Schedule for internal examinations is communicated to the students well in advance by the class coordinator despite mentioning the same in the academic calendar.
2. **Syllabus:** The syllabus for the internal examination is also communicated to the students in the classroom by subject teacher one week in advance.
3. **Setting of question papers:** Subject teacher set the question paper keeping Programme Outcomes (POs), Course Outcomes (COs), unitized syllabi and University examination pattern in consideration. Bloom taxonomy (BT) is also mentioned in the question paper by respective subject incharges. Question papers are submitted to house examination committee three days before the commencement of the internal assessment test.
4. **Conduct of internal assessment:** Internal assessment test is conducted as per the seating plan communicated to the students. The seating plan is displayed on the board provided beside the classroom doors.

5. **Communication of IA marks:** Internal Assessment (IA) marks are announced and the answer sheets are distributed in the class within the next three days from the test. Sessional marks are displayed on the notice board. The students are given a chance to bring their grievances if any to the concerned subject teacher and if satisfied with the marks they mention it on their answer sheet with the phrase- Seen and satisfied with their signature and date.
6. **Submitting MST marks to University:** For each subject, two internal assessments are conducted and sessional marks are recorded in the consolidated Award mark sheets. The best of the two internal assessments with respect to each student is considered and the same is uploaded in the RGPV university portal.

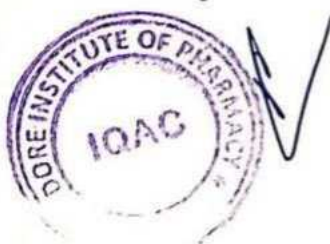
The committee comprises of –
