### Survey

A health checkup of 218 Patients was conducted. IIP faculties conducted blood group testing of 75 school students, which was requested by their School principals for records and data and analyzed data

They stated:

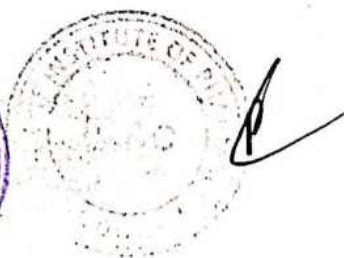
- Majority of the patients were, above 55 years. Out of which around 60-hypertensive patients;

This is because customers are more likely to continue using and recommending your product or service if it solves a problem they have in a meaningful way.

Group Advisor Sir presented a planter and a book as a token of appreciation to Mr. Jay Jain

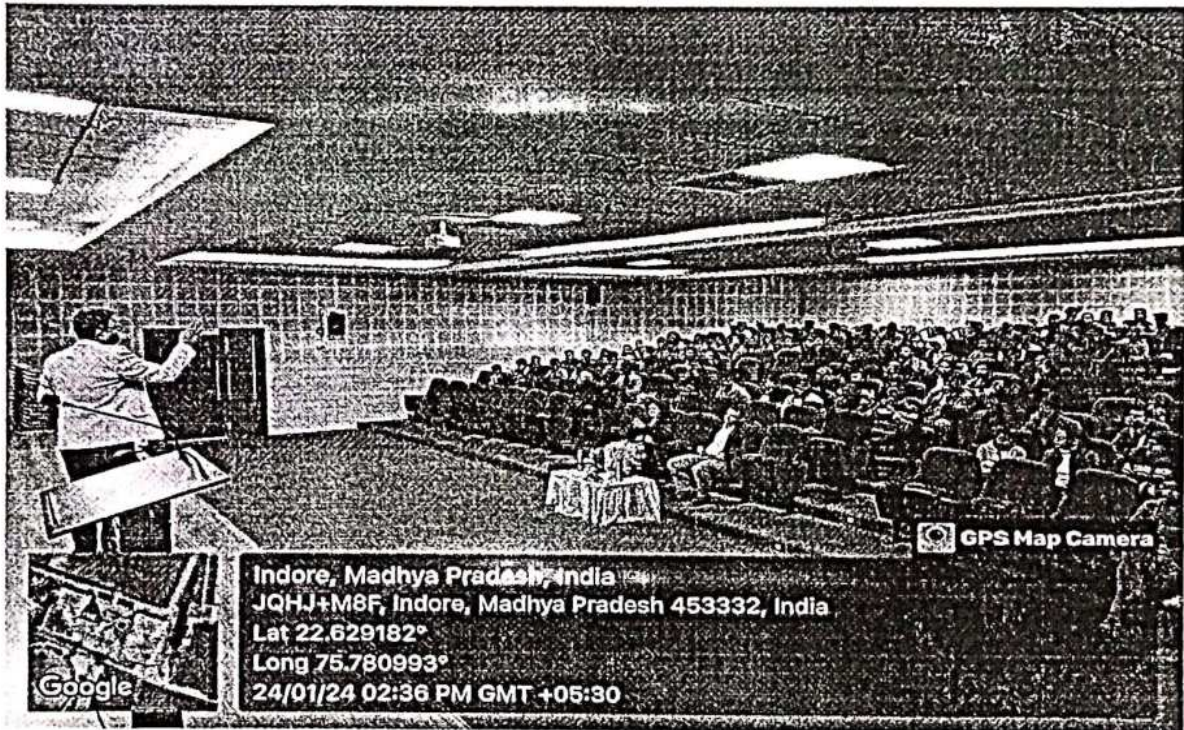

People gathering there were asked to practice good hygiene especially and quiz was played among them to motivate for a healthy lifestyle.

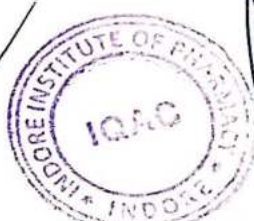

Educate students about the harmful effects of ragging on mental and emotional well-being.

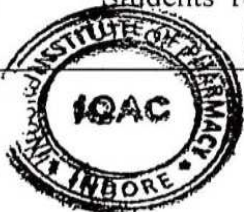
Encourage positive interactions and mutual respect among students.

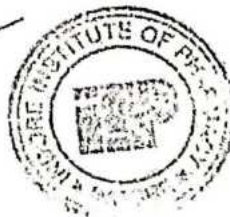
## REPORT ON BLOOD DONATION CAMP

### **PARTICIPANTS:**

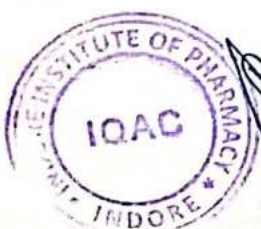
The competition witnessed enthusiastic participation from students. Participants were divided into 5 teams, ensuring a diverse mix of knowledge and expertise.
