### 7.1.3 Describe the facilities in the institution for the management of degradable and non-degradable waste:

#### Solid waste management:

- Pollution from waste is aesthetically displeasing and results in large amounts of litter in our communities which can cause health problems.
- Solid waste can be categorized into three types: biodegradable, non-biodegradable and hazardous waste.
- Bio-degradable wastes include food wastes, canteen waste, wastes from toilets etc. Non-biodegradable wastes include plastic, tins and glass bottles etc. Hazardous waste is waste that is likely to be a threat to health or the environment like cleaning chemicals, acids and laboratory chemicals.
- Each and every department of our institute as well as offices staff create some waste and dumped in small waste bin located in the department.
- In our building several dust bins are placed from where housekeeping staffs take the wastes. From the small bin wastes are dumped in big bin by the housekeeping staffs regularly. From the big waste bins the vehicles from **Rangwasa Gram Panchayat** took the solid wastes.
- Bio-degradable wastes are effectively converted to fertilizer at a very small scale in our laboratories by **composting technology** inside the campus and given a proposal to design and execute a small plant for producing organic fertilizer from garden waste and kitchen food waste.
- The use of fertilizers will provide an environmentally friendly, naturally sustainable, safe and affordable means for maintaining soil fertility and increasing crop production. After segregation of biodegradable waste from canteens, residential quarters, Hostel and guest houses are collected and dumped in the composting unit in the campus.
- Institute **discourages uses of plastic**; particularly single use plastics in campus.
- Institute also produces lot of paper waste. Paper wastes from Academics, Library, exam department, Administrative offices, Hostels, Guest Houses are disposed **through vendors**.
- The wastes are properly stacked in designated place and later disposed through vendors for **proper waste management**. We use single printed paper for stationary in office and other required work.

#### BIODEGRADABLE WASTE:

##### Conversion of Biodegradable waste in our Laboratory

- Biodegradable waste is converted to fertilizers in a small-scale lab in IIP. It involves processes such as composting or anaerobic digestion for breaking down organic materials into valuable product.

**Procedure:** Materials are collected, chopped into smaller pieces. They are packed in layers in the compost bin or pile alternating between green material (food scraps) and brown material shredded newspaper or dry leaves. It is kept moist and aerated. After few weeks, the compost is ready for use as fertilizer.

#### Liquid waste management:

- Liquid waste is generated from Science laboratories, Hostels, Residential quarters and canteen. Liquid wastes generated by the institute are of two types: 1. Sewage waste. 2. Laboratory, residential washing and canteen effluent. The liquid wastes are mainly drained to **improve the ground level of water.**

#### E-waste management


- Indore Institute of Pharmacy has very efficient mechanism to dispose E wastes generated from various sources.
- E-wastes are generated from computer laboratories, various Labs, Academic and Administrative Offices.
- The e-waste includes out of order equipment or obsolete items like lab instruments, circuits, desktops, laptops and accessories, printer, charging and network cables, Wi-fi devices, sound systems, display units, UPS, Biometric Machine, scientific instruments etc. All these wastes are put to optimal use.
- All such equipment's which cannot be reused or recycled is being disposed off and managed by **Unique Eco Recycle Company.**
- Instead of a new procurement Buy-Back option is preferred for technology up gradation.

#### Waste Recycling System:

- Degradable solid waste collected from cafeteria, Boys and Girls Hostels, Guest Houses, canteen and from Residential Quarters is dumped in the decomposing Unit to make some Organic fertilizer which is used for Gardening and agriculture.
- The waste produced in our canteen and lawns is disposed in **four decomposing pits** for the production of organic manure.

#### Hazardous Chemicals System:

- The hazardous chemicals used in laboratories are managed by our store department. Acids and other harmful chemicals are issued in control register by technician only. The used acid is drained in drainage system by **diluting in the ratio of 1: 10.**

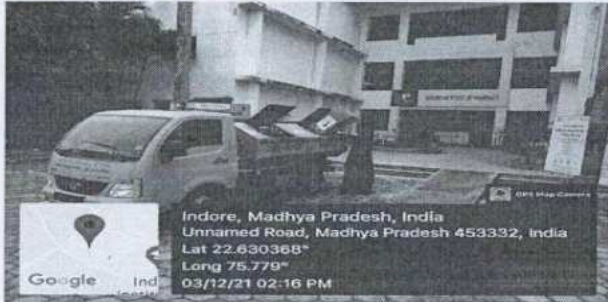



## IIST-IIP-IIMR

There is an requirement of properly disposing e-waste (Electronics and Electrical) of IIST-IIP-IIMR. This e-waste has to be handled by a state government and pollution control board authorised agency. This will be as per the green policy of the SLWS and the 3 institutes, IIST-IIP-IIMR.

M/s Unique Eco Recycle, Palda, Indore is an authorised agency certified by the above statutory bodies.

The agency has been associated with many industries, colleges and universities in Indore. IIST-IIP-IIMR has been in contact with Unique Eco Recycle for the past some time for awareness of e-waste management. A formal MOU is to be signed between them and Shall Group of Institutions, comprising IIST-IIP-IIMR.

A meeting with Dr. Fazal from Unique Eco was scheduled and done, with the undersigned representatives of IIST-IIP-IIMR, for further finalising the association.

After initial talks, MOU terms were discussed;

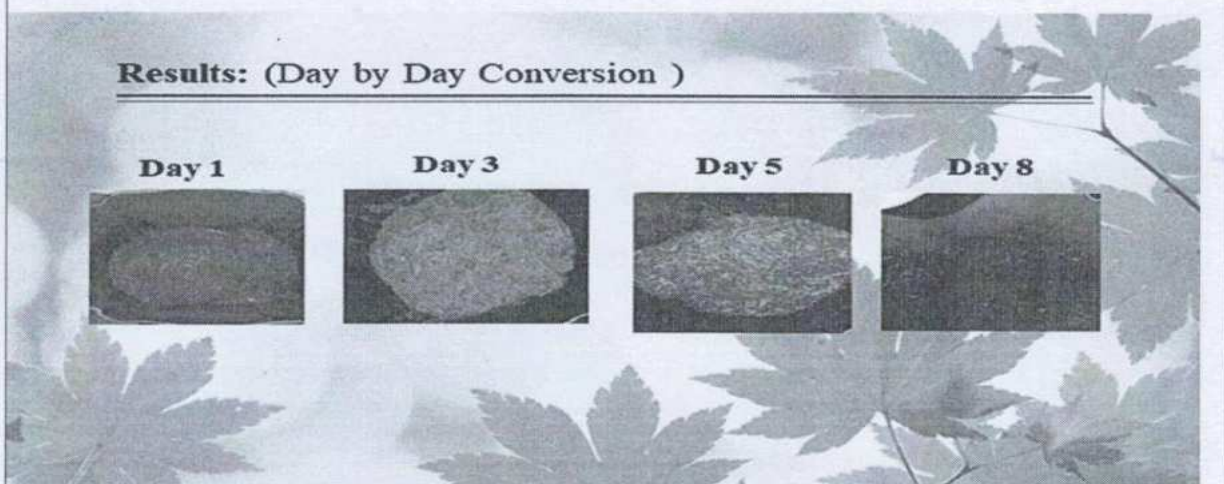
