7.1.1: Measures initiated by the Institution for the promotion of gender equity.

- Indore Institute of Pharmacy is a co-education college so fundamental tenets of gender equity are inherent in every aspect of our functionality. The gender ratio of female student's admission has notably increased to 38% as compared to 30% in last five years.
- We honour the admission policy drafted as per the RGPV.
- As per our gender equity policy the Institution also provides equal opportunity to females and males in terms of employment at various positions. The ratio of female faculty in IIP is 54%.
- The institution has adopted a gender policy and constitutes a committee therein which looks after the conduct of various activities that promote gender equity at institutional level.
- All faculty and staff are treated equally in assigning their roles and responsibilities, duties and privileges. They are provided with equal rights, resources and opportunities.
- Similarly, the gender equity principle is followed by the faculty in academic, cocurricular and extracurricular events thereby rendering equal opportunity to male and female students for participation and excellence like group dances for both girls and boys and in fire less cooking.
- The matter of Gender equity is further strengthened by the syndicate program
 wherein student mentees are counselled irrespective of their gender by their faculty
 mentors in case of any academic, personal, health or social issues in a sensitive
 manner.
- Special drives are taken to sensitize the students and employees to spread awareness
 regarding gender issues for preventing any kind of discrimination whatsoever. These
 include Women's Empowerment and awareness programs, established and functional
 internal complaints Committee (ICC) following the SAKSHAM guidelines.
 - For the safety and security of all students and employee, especially for women, the campus and buildings are under constant CCTV surveillance, security guards are posted at the gates and in front of Girls' Hostel, all buildings are provided with Fire-Extinguishers and an automated fire-alarm with all associated fire-fighting equipment are installed in the campus.

- A team of counselors is available at the institute on full-time basis, for proper guidance and counseling of the students. Institute is also following a syndicate system on each 15 students in a class. Syndicate incharge is creating a friendly atmosphere to each student in his syndicate group so that student can share his/her problems in college.
- The institute provides comfortable stay facilities in boys and girls hostels with wardens. Interactive sessions on Women empowerment and safety are organized at regular intervals.
- Day care centre is available in girls hostel premises for the care of children's of the
 employees.
- Separate hostel facilities are provided for both girls and boys for their comfortable stay. Separate wardens for hostels are appointed for monitoring the care.
- IIP gives equal opportunities to both genders. We encourage physical fitness and believe sports brings in confidence, discipline, Strength (Physical & mental), we have teams for girls and boys in all games. Both teams participate in college, university band State level.
- All students irrespective of gender, are taken for industry visits and training.
 College buses are provided and safety of students is ensured.







REPORT ON WOMEN'S EQUALITY DAY 2022

On the occasion of Women's Equality Day on 26th August 2022, Rangoli Competition was planned on the theme "Thanks women in your life". The approval for the Rangoli Competition was taken and immediately preparations were started. Notice and circular were prepared and circulated among all the students.

Conception

Women's Equality Day is celebrated on August 26 to commemorate the 1920 adoption of the 19th Amendment, which granted some women the right to vote. 



Lastly, program coordinator conveyed vote of thanks.


